In much of the world, sending and receiving invoices electronically requires compliance with government regulations for electronic invoicing (eInvoicing) and, increasingly, with government mandates for business to government (B2G) eInvoicing. In some countries, eInvoicing is mandated for business to business (B2B) transactions, with governments requiring eInvoicing be submitted to the tax authority or their approved agent before they can be sent to customers.

These government regulations differ from country to country and maintaining compliance with each is a significant challenge for global businesses. Despite this, companies that move to eInvoicing see positive results through digitizing, automating and optimizing their AR and/or AP processes, including decreased errors, reduced processing costs and better cash flow management.

When paper is eliminated via eInvoicing, governments require an archive of electronic documents, including the eInvoice and supporting documents. Active Invoices with Compliance provides archiving with specific capabilities to support auditor access and review of archived eInvoicing and supporting documents.

OpenText helps organizations meet government mandates for eInvoicing, including:

- Agency regulations requiring government sponsored portals.
- Rules for eInvoicing handling and archiving when eliminating paper.
- eInvoicing requirements, allowing agencies to view eInvoices before they are sent to customers.

Global EDI network

An eInvoice is only one B2B document among many and is usually part of a global EDI/ B2B rollout. OpenText offers a global EDI network, supporting both inbound and outbound compliant eInvoicing, while also exchanging transaction documents that cover the entire business process. Additionally, for Accounts Receivable departments with many small customers, OpenText supports sending signed PDF eInvoices.

Some eInvoicing providers support only inbound invoice processing for Accounts Payable, while requiring that all suppliers join the provider's network. OpenText's open network approach enables both outbound and inbound eInvoicing, while supporting direct connections, EDI VAN, trading networks, vendor portal/web forms and a variety of other options.

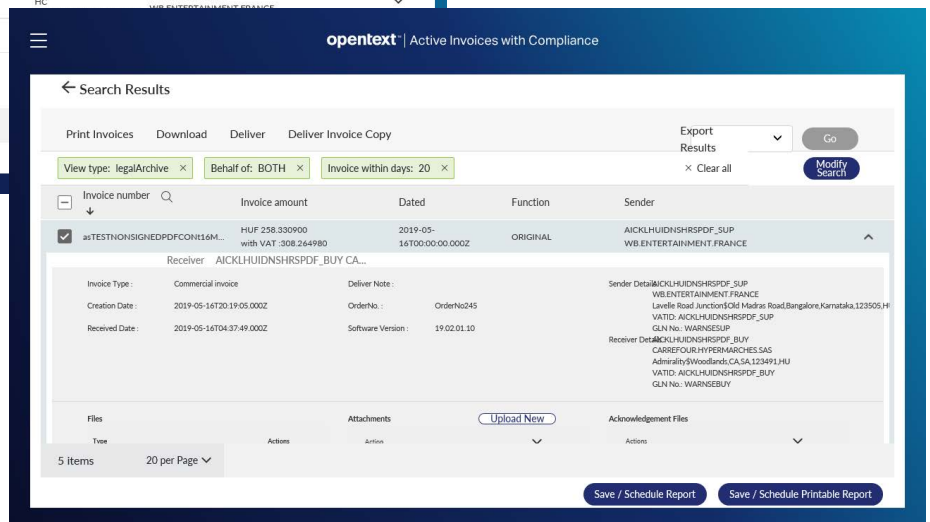
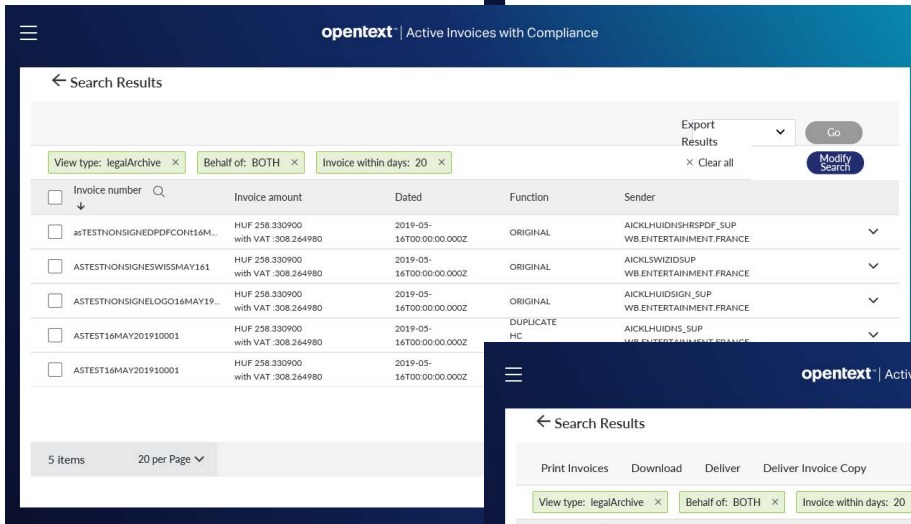
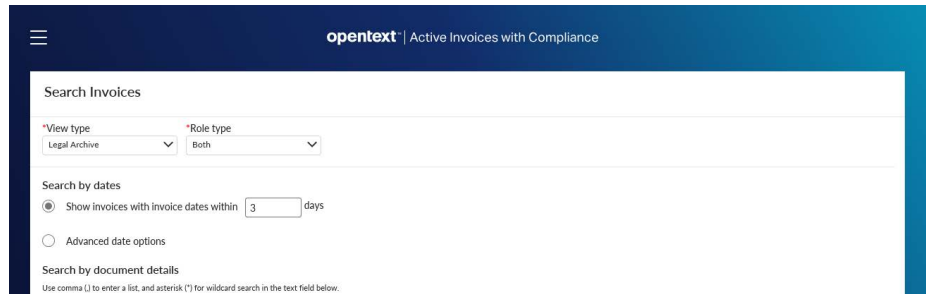

Business to government eInvoicing

Many governments mandate that businesses selling to government entities, such as state or local governments, public institutions, schools or hospitals, must invoice electronically, especially in the European Union (EU), where EU directives mandated that member states create B2G eInvoicing rules by November 2018.

With legislation spreading, global businesses need to be ready to meet B2G eInvoicing mandates in the countries they do business. Even where organizations have a program, eInvoicing may not be in the proper format and organizations may not be appropriately connected to deliver eInvoicing to public entities in each country. The ability to generate documents in the right format and deliver them via tested connectivity will help organizations maintain compliance, decrease errors, reduce processing costs and improve cash flow management.
